**CW5 Deshawn L. Bell assumed duties as the Regiment's fifth Regimental Chief Warrant Officer (RCWO) at Fort Gordon, GA on 16 October 2016. CW5 Bell previously served as the Command Chief Warrant Officer for 3rd Signal Command (Theater), Fort Shafter, HI, August 2015 – August 2016. He was the Senior Operations Technician and was the primary technical advisor on all network and system integration, especially as it related to strategic-to-tactical systems integration within US Army Pacific (USARPAC) Theater.**

**CW5 Bell proudly hails from Colorado Springs, CO. He is a 1987 graduate of Roy J. Lunn Signal School in Colorado Springs, CO. He entered the US Army in July 1988 as a Programmer/Systems Analyst (MOS 74F). From 1989 – 1996, he served at Ft. Huachuca, Arizona; Harbor, Hawaii; and Alexandria, VA. He was selected to attend the Warrant Officer Basic Course at Signal School in 1996, and was appointed a Warrant Officer One (WO1) in the Signal Corps. After completing the Warrant Officer Basic Course at Ft. Gordon, he was stationed at Ft. Gordon in 1997 and served as the Automation Section OIC of the Corps Logistics Automation Office supporting the 1st Corps Support Command (Airborne). In 2000, he was assigned to Wainwright, AK where he served as the OIC of the Combat Service Support Management Office (CSSAMO), supporting 172nd Infantry Brigade (Separate) and US Army Alaska (USARAK). In 2004, after attending the Warrant Officer Advanced Course, he was assigned to Lewis, WA where he assumed duties as the I Corps G6 Data Network Planner, supporting numerous operational missions throughout the Pacific. He attended the Warrant Officer Advanced Course during this assignment. In 2007 he deployed to Camp Arifjan, Kuwait supporting the Signal Command (Theater) and the US Army Central (ARCENT) Forward. He was further deployed to Kabul, Afghanistan and Camp Victory, Iraq as a Network Architecture Technician and**
